

Manor Maintenance Plan gives you

Routine preventive care from your dentist which includes:

- ✓ Check-ups*

Manor Maintenance Plan does not cover:

- ✗ Restorative dental treatments including fillings, crowns, bridges or dentures
- ✗ Laboratory fees and prescriptions
- ✗ Any dental treatment such as fillings
- ✗ Referral to a specialist and specialist treatment
- ✗ Orthodontics, implants, cosmetic treatment
- ✗ Sedation fees

As part of Manor Maintenance Plan you receive Denplan Supplementary Insurance which provides:

- ✓ Temporary emergency dental treatment in the UK (up to £450 per incident. Maximum amount payable £900 per calendar year)
- ✓ Temporary emergency dental treatment when overseas (up to £470 per incident. Maximum amount payable £940 per calendar year)
- ✓ Up to £62 for each night you stay in hospital under the care of a dental or maxillofacial surgeon for dental treatment for up to one year
- ✓ Up to £12,000 towards one course of mouth cancer treatment for up to 18 months following diagnosis (smokers are included)

- ✗ Emergency dental treatment provided by your own dentist or a dentist/specialist acting on your dentist's behalf
- ✗ Dental injury caused whilst training for or participating in contact sports, unless appropriate mouth protection is worn
- ✗ Mouth cancer diagnosed before joining Denplan or within 90 days after the date you joined Denplan (or for which tests or consultations began within those 90 days)
- ✗ Mouth cancer situated in the tonsils

Your payment is collected by Denplan monthly by Direct Debit. A one-off registration fee is payable to Denplan when you join.

If you choose to leave the plan for any reason you can do so by simply giving us one month's notice.



Emergency cover

As part of Manor Maintenance Plan you will have worldwide dental injury and dental emergency cover (Denplan Supplementary Insurance).

This includes:

- Temporary emergency dental treatment when you are more than 40 miles away from your own dentist in the UK
- Overseas temporary emergency dental treatment
- Worldwide dental injury and dental emergency cover
- Hospital cash benefit if you need to stay overnight in hospital for dental treatment under the care of a dental or maxillofacial surgeon
- Mouth cancer cover (cover not immediate)
